

COVID-19 SAFETY ACKNOWLEDGMENT AND RELEASE OF LIABILITY WAIVER

COVID-19 SAFETY INFORMATION

Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, Prairie Island Indian Community d/b/a Treasure Island Resort & Casino (hereinafter referred to as "TIRC") has put in place preventative measures to reduce the spread of COVID-19. However, TIRC cannot guarantee that its participants, guests, visitors, volunteers, and attendees (collectively, the "Individuals") who will attend concerts (a "TIRC Event") will not become infected with COVID- 19.

Individuals who fall within any of the categories below should not attend a TIRC Event. By attending a TIRC Event, you certify that you do not fall into any of the following categories:

1. Individuals who currently or within the past 14 days have experienced any symptoms associated with COVID-19, which include fever of 100.4 or above, chills, coughing, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of smell or taste, sore throat, congestion or runny nose, nausea or vomiting, and diarrhea. This list of symptoms may be expanded based on developing CDC guidance.
2. Individuals that are diagnosed with COVID-19.
3. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or are told by a treating health care provider that he or she is presumptively positive for COVID-19 and are not yet cleared as non- contagious by state or local public health authorities or the health care team responsible for their treatment or are tested with a negative result. Individuals with an exposure to someone with confirmed or suspected COVID-19 are not required to quarantine if he or she has been fully vaccinated and have remained asymptomatic since the COVID-19 exposure.

RELEASE OF LIABILITY, WAIVER OF CLAIMS

I am aware that attending a TIRC Event has many inherent risks. I acknowledge that there are hazards and risks of physical injury or illness to attendees at TIRC Event and that not all such hazards or risks can be fully eliminated, which include Covid-19. While particular rules and policies may reduce this risk, the risk of serious illness and death does exist. I freely and voluntarily agree to assume the full risk of illness, such as Covid-19 and the potential for death, bodily injury or property damage, regardless of severity, that I (or my child) may sustain as a result of my attendance at TIRC Event, whether or not caused by the negligence or gross negligence of TIRC or others attending the TIRC Event.

By purchasing a ticket to TIRC Event and/or by attending a TIRC Event, I agree that I am waiving certain legal rights. In consideration of TIRC permitting my attendance at TIRC Event, I waive any and all claims that I may have against TIRC in the future, and release TIRC from all liability for any claims of personal injury, death, property damage or other loss that I sustained during or as a result of the TIRC Event due to any cause whatsoever. I covenant not to sue TIRC for all liability to me, my children, my personal representatives, assigns, heirs and next of kin, for any claims, causes of action, obligations, lawsuits, charges, complaints, controversies, damages, costs or expenses of whatsoever kind, nature, or description, whether direct or indirect, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, arising out of or connected with my (or my child's) attendance at a TIRC Event or while on the TIRC premises, whether or not caused by the negligence or gross negligence of TIRC, anyone working at the TIRC Event, or by me (or my child) attending TIRC Event.
